Dear President Trump:

The undersigned organizations work to combat human trafficking in the United States and around the world. As such, we understand the extensive harm that results when coercion or physical violence are used to force an individual, particularly a child, to engage in commercial sex. Although we do not minimize or diminish the severity of Lisa Montgomery's offense, we unequivocally support her clemency in light of the extremity of her history of sexual abuse and trafficking victimization. Lisa Montgomery's execution is scheduled for December 8, 2020. We urge you to commute her sentence to life without the possibility of parole.

Prior to committing this offense, Lisa Montgomery experienced every type of abuse imaginable. Her childhood was replete with sexual abuse, physical violence and trafficking into commercial sex. As advocates who raise awareness about human trafficking, create system responses that better identify and protect trafficking victims, and support those recovering from sexual exploitation, we understand why Lisa's history is so relevant to determining how she should be punished for her crime.

Lisa was born with permanent brain damage as a result of her mother's alcohol intake during pregnancy. Sexually abused by her stepfather as a young girl, Lisa was repeatedly raped in her home for years. Brutal physical violence accompanied the sexual abuse. Lisa's mother began trafficking her to men for sex when Lisa was a young teenager. Lisa developed dissociative disorder and complex post-traumatic stress disorder as a result of the repeated rapes she suffered.

Like so many other trafficking victims, the very systems that were supposed to protect Lisa did not, rendering her vulnerable to ongoing exploitation and abuse. School and child welfare authorities failed to intervene, despite indications that Lisa was being abused. Social services removed her older sister from the home, but left Lisa behind.

As experts on sex trafficking and its impact on victims, we know that Lisa's prior victimization doesn't excuse her crime. Nonetheless, it provides critical context that explains why she committed these acts, which might otherwise seem incomprehensible. Lisa is a victim of trafficking and extensive trauma with serious mental health issues, including dissociative disorder directly linked to her experiences of sexual violence. Despite being mischaracterized at her trial as an "abuse excuse," Lisa's victimization is inextricably connected to the crime she committed.

At the time of Lisa's prosecution, we did not know as much as we do now about the devastating harm caused by the commercial sexual exploitation of a child. Since Lisa's

sentencing, our legal system has evolved to reflect this understanding through the proliferation of a body of law aimed to protect child trafficking victims like Lisa. Had any of these laws been in effect when Lisa was a child or young adult suffering human trafficking, our legal systems would have offered more meaningful intervention.

No one can go back in time to remedy the wrong that was done to Lisa. But you can keep her from suffering the ultimate injustice by commuting her sentence. Lisa has suffered some of the worst forms of sexual violence, and we know that victims of such violence experience lifelong psychological damage. Under these circumstances, we urge you to grant her clemency as an appropriate and just extension of mercy.
